



Overview

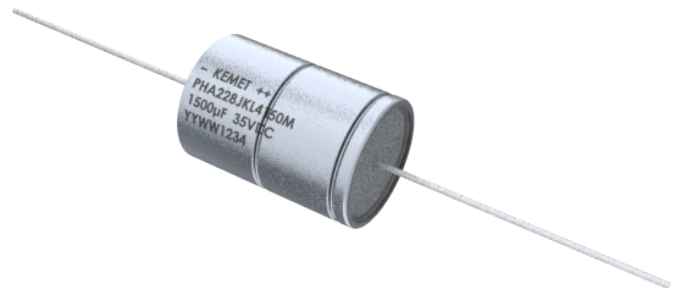
KEMET's PHA228 is a High CV conductive polymer hybrid capacitor with outstanding electrical performance. The device has a polarized all-welded design, tinned copper wire leads, and a negative pole connected to the case. The PHA228 winding is housed in a cylindrical aluminum can with a high purity aluminum lid and high-quality rubber gasket. Low ESR is conditioned by a highly conductive polymer (PEDOT/PSS) and an all-welded design. The polymer system creates an electrical pathway between the anodic oxide layer and the cathode through a mechanical separator - paper. The PHA228 winding is impregnated with liquid electrolyte that results to self-healing features of the capacitor. Thanks to its mechanical robustness, the PHA228 is suitable for use in mobile, automotive and aircraft installations with operation up to +150°C.

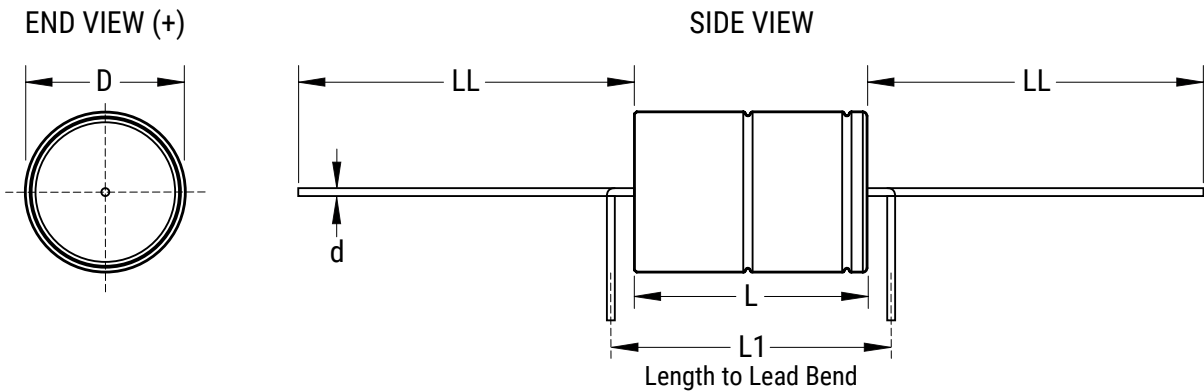

Shelf Life

The capacitance, ESR and impedance of a capacitor will not change significantly after extended storage periods at temperatures up to 40°C, however the leakage current will very slowly increase. After storage for 10 years at +40°C or 1,000 hours at maximum rated temperature with no voltage applied and then being stabilized at +20°C, capacitors shall meet the limits specified in Endurance.

Environmental Compliance



All Part Numbers in this datasheet are Reach and RoHS compliant and Halogen-Free.

In Europe (RoHS Directive) and in some other geographical areas such as China, legislation has been put in place to prevent the use of some hazardous materials, such as lead (Pb), in electronic equipment. The only material of concern in our products has been lead (Pb), which has been removed from all designs to fulfill the requirement of containing less than 0.1% of lead in any homogeneous material. KEMET will closely follow any changes in legislation world wide and makes any necessary changes in its products, whenever needed.

Some customer segments such as medical, military, and automotive electronics may still require the use of lead in electrode coatings. To clarify the situation and distinguish products from each other, a special symbol is used on the packaging labels for RoHS compatible capacitors.

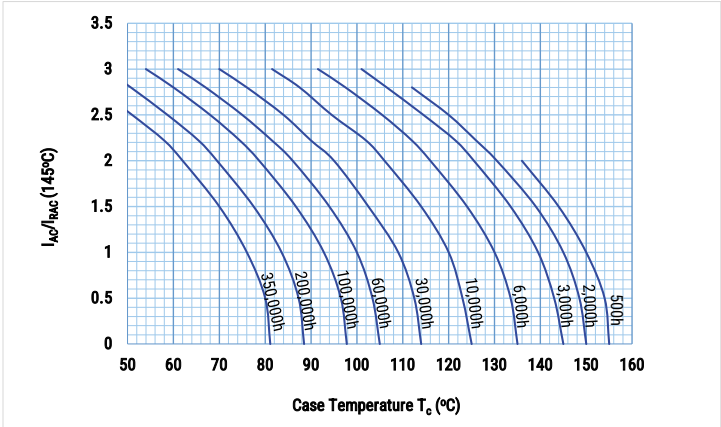

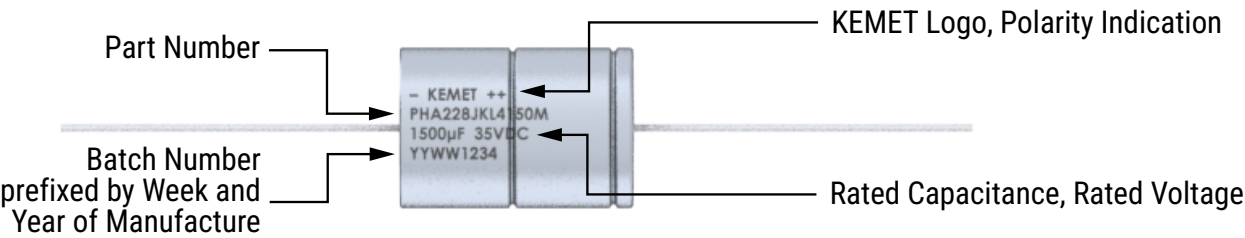

Operational Life

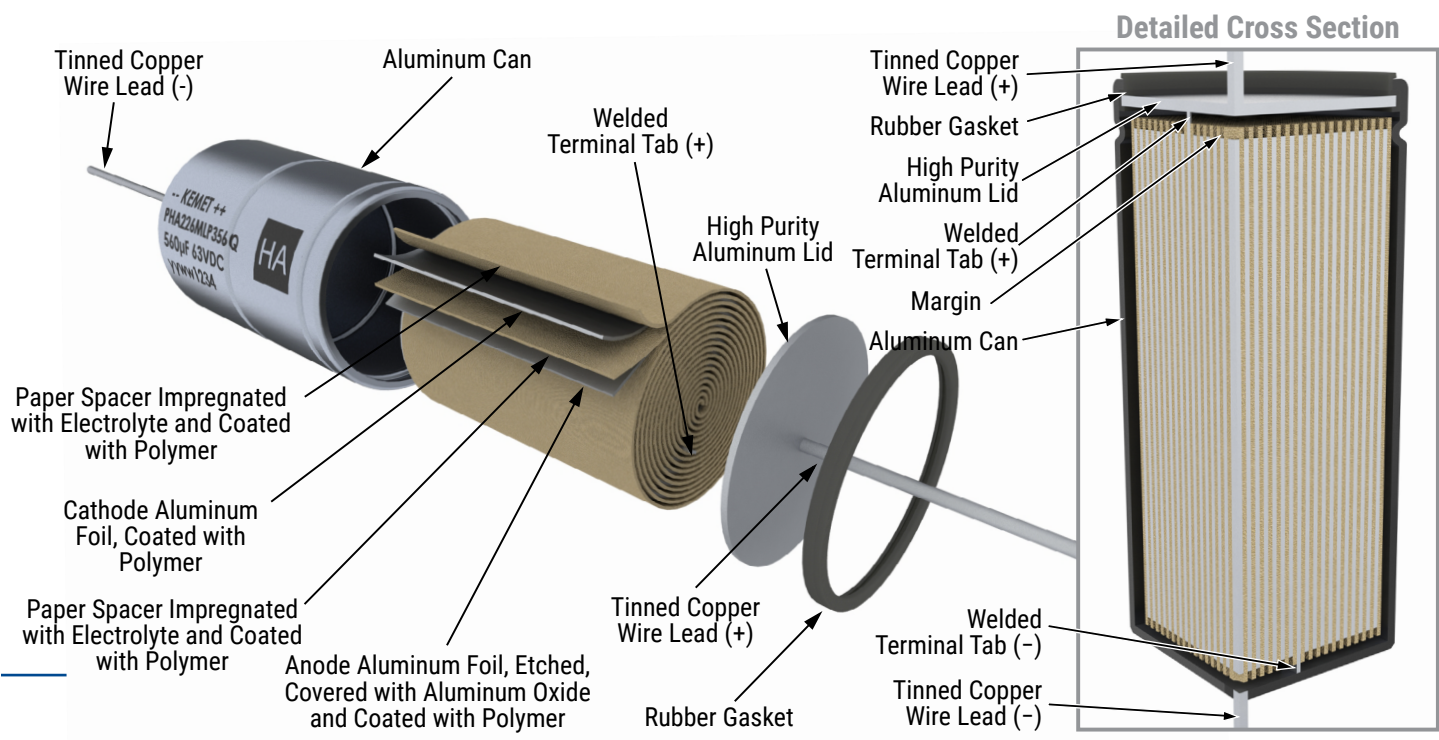
Operational life (L_{op}) at case temperature T_c and ripple current I_{AC}.

Construction Data

The manufacturing process begins with the anode foil being electrochemically etched to increase the surface area and then “formed” to produce the aluminum oxide layer. Both the anode and cathode foils are then interleaved with absorbent paper and wound into a cylinder. During the winding process, aluminum tabs are attached to each foil to provide the electrical contact.

The winding is assembled to the capacitor Al-can and to the Al-lid. The can is filled with electrolyte and the winding is impregnated during a vacuum treatment. The capacitor is sealed. Throughout the process, all materials inside the housing must be maintained at the highest purity and be compatible with the electrolyte. Coating with polymer is applied during manufacturing process to achieve enhanced performance.

Each capacitor is aged and tested before being packed. The purpose of aging is to repair any damage in the oxide layer and thus reduce the leakage current to a very low level. Aging is carried out at elevated temperature and is accomplished by applying voltage to the device while carefully controlling the supply current. The process takes between 2 and 20 hours, depending on voltage rating.

Damage to the oxide layer can occur due to a variety of reasons:

- Slitting of the anode foil after forming
- Attaching the tabs to the anode foil
- Minor mechanical damage caused during winding

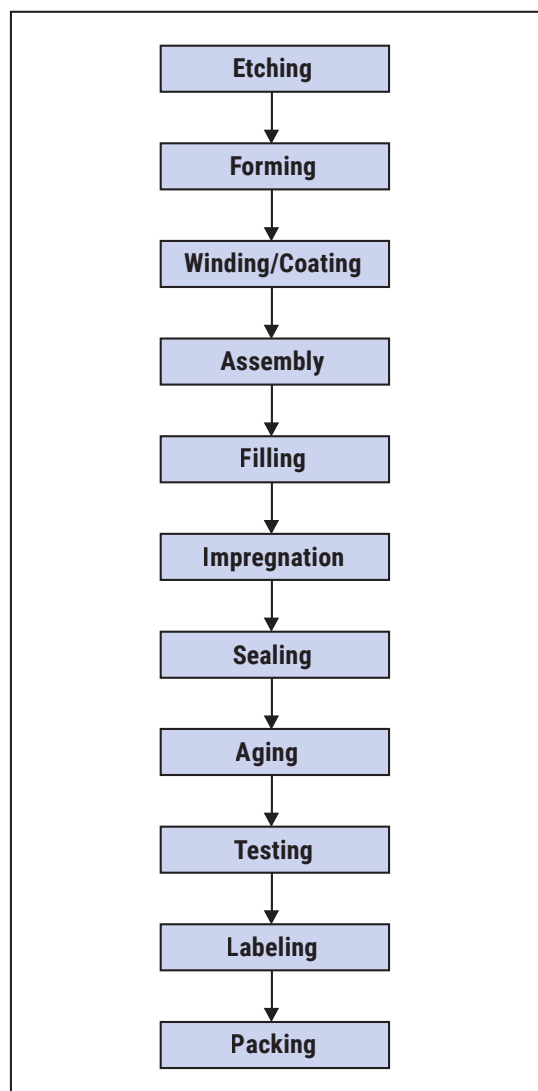
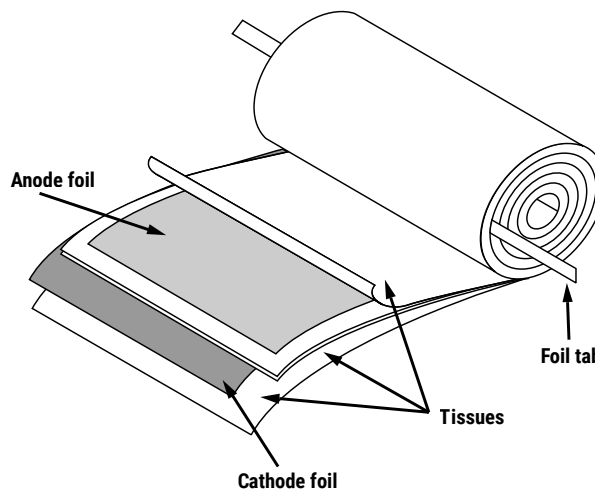

- Leakage current
- Capacitance
- ESR
- Tan Delta

Mechanical/Visual:

- Pull strength test of wire terminals
- Print detail
- Box labels
- Packaging, including packed quantity
